

**Support for Pioneering Research Initiated by the Next Generation (SPRING Project),
University of Toyama**

Application Guidelines for Academic Year 2024 (April 2024-) Support Program

Aim of the program

The University of Toyama (hereafter referred to as "the University") will start to offer an intensive "Support for Pioneering Research Initiated by the Next Generation ("Tateyama Mountain Range Program")" from April 2024. This program provides financial support and various training for PhD course students for their future success in various career paths after completing the program. The program will not only promote highly motivated and talented students towards the advanced stage of PhD dissertation research projects but also improve the research activity of the University, which leads to the promotion of regional industries, including medicine, healthcare, light metals, and carbon neutrality. This program also aims to improve Japan's international competitiveness by developing skillful graduates who can contribute to the settlement of global issues.

The application procedure is explained below. The recipients will be provided with a research grant and research expenses as a stipend and special training to improve their research skills and career paths.

1. Total number of scholarship recipients

Application Category A for ca. 12 persons who will be enrolled in the first grade of the PhD course in Academic year 2024 starting from April 1, 2024.

Application Category B for ca. 2 persons who will be enrolled in the second grade of the PhD course in Academic year 2024 starting from April 1, 2024.

2. Eligibility for Application

The program is open to students enrolled in the doctoral program of the Graduate School of the University of Toyama, who have excellent research skills and are expected to contribute to the development of science and technology and the creation of innovations in Japan in the future.

However, those who fall under any of the following items are not eligible.

- (1) JSPS Research Fellowship for Young Scientists (If you are Adopted the JSPS Research Fellowship, you must decline to support this project (cannot be accepted to both).
 - (2) Those who have received a sufficient level of scholarship (2.4 million yen or more per year) for living expenses.
 - (3) Those who are recognized as having a stable income of 2.4 million yen or more per year as living expenses from the university or company to which they belong, such as salary, executive compensation, etc.
 - (4) International students receiving support through the Japanese Government Scholarship Program or scholarships from their home country.
- If you are currently receiving a scholarship from a foundation, etc., if you have been selected to receive a scholarship, or if you are in the process of applying or considering applying for a scholarship, please be sure to contact us as indicated in "**12. Inquiry**". (We will confirm your application in advance because there are

cases in which the scholarship and the SPRING Program are not approved at the same time.)

- If you are selected for this program, you will not be able to apply for scholarship repayment waiver by the Japan Student Services Organization (JASSO).
- If you have any questions about eligibility, please refer to “12. Inquiry”.

3. Amount to be paid as the research support funds

The research support funds to be provided under this project will be as follows:

- (1) Research scholarship: 180,000 yen per month (2,160,000 yen per year)
- (2) Research expenses: 500,000 yen per year
 - The research scholarship is provided as an amount equivalent to living expenses so that the student can devote himself/herself to research.
 - The research scholarship will be paid every two months upon receipt of invoices from the students to be supported.
 - The research scholarship does not have to be repaid (except in the case of fraudulent applications, etc.).
 - Research expenses are to be used appropriately in accordance with the University's regulations.
 - International students will receive a research scholarship and a research expenses after their arrival in Japan.

4. Career development and training content to be provided

This project provides a program that aims to develop the following abilities (1) to (4) so that the recipients will be able to play an active role in various career paths in the future.

- (1) Career Development
 - Long-term internships in cooperation with local industry
- (2) Cultivation of internationality
 - Dispatch overseas to partner universities and overseas collaborative research sites
- (3) Cultivation of interdisciplinarity
 - Interdisciplinary research through active use of different disciplines and sub-supervisors
- (4) Transferable skill acquisition
 - Convergence Camp (where all students across disciplines present their research and discuss their presentations with their advisor, subadvisor, other students, and faculty members)

5. Period of support (Estimated)

April 2024- In principle, within the standard term of study

For doctoral and postdoctoral students whose standard term of study is three years, the scholarship will be provided until the third year of study.

Doctoral students whose standard term of study is four years will be granted until their fourth year.

Please note that the support may be cancelled even within the above period if the student takes a leave of absence, withdraws from school, or is judged to be inadequately fulfilling his/her obligations, as specified separately.

6. Application Procedures

The applicant should submit the application form (Form 1) and the letter of recommendation from the possible supervisor at University of Toyama (Form 2) to the administrative office of the corresponding

graduate school whose contact information is shown below. Within one week after receiving your application, the SPRING project office will send you an e-mail to acknowledge receipt of your application.

NOTE 1: The applicant should fill out the application form herself/himself; the form prepared by someone other than the applicant cannot be accepted. The applicant may fill out the form in Japanese or English.

NOTE 2: Please include an email address that will be available from April 2024 onwards. Do not use the email address issued from the master course of the graduate school of University of Toyama because it will no longer be available in April 2024.

Deadline for submission: Wednesday, March 27, 2024, 12:00 (noon)

Method of submission:

Application form (Form 1): Submit by e-mail the MS Word file as an attachment.

Note: The application form prepared by a person other than the applicant cannot be accepted. If you have a difficulty to prepare the form in Japanese, please use English.

Letter of recommendation (Form 2): Submit by regular mail t by a printed copy of the form with the signature of the University faculty member who is the candidate supervisor of the applicant.

7. Selection and notification of results

The recipients will be selected based on the decision made by the Selection Committee. The committee will judge the eligibility of the applicants by examining the submitted documents and through interviews. The final decision will be made by the Project Director.

Interviews will be held at the Gofuku Campus between Monday, April 8, 2024 and Wednesday, April 10, 2024. The details will be explained in the e-mail confirming the receipt of your application.

The results of the final decision will be notified by e-mail by late April.

To be considered for the scholarship, the student must be enrolled in a designated grade of the PhD program as of April 1, 2024.

8. Selection Perspectives

In selecting students to be supported by this project, the following grades will be used as reference points.

(1) Achievements related to conference presentations, patents, papers, and languages up to the time of application

- 1) Conference presentations
- 2) Patent application
- 3) Original papers and other publications
- 4) External language examinations

(2) Research plans, internship and study abroad plans prepared by students

- (1) Novelty, importance, relevance, etc. of the research plan, including future development potential
- (2) Plans and aspirations for internship or study abroad

NOTE: The scholarship recipient should participate in an internship or study abroad to develop their career.

The applicant who is willing to seek a future job in the industrial sector should state her/his motivation and plan for an internship. The applicant who is willing to seek a future job in the academic sector should state her/his motivation and plan to study abroad.

(3) Motivation to become a researcher or developer working in a Japan-based firm or institute who will play a leading role in the future science, technology and innovation in Japan

NOTE: This scholarship program aims to support graduate students who will contribute to the development of science, technology, and innovation in Japan. We strongly recommend that the scholarship recipients take a job in Japan-based firms or institutes including their overseas branches after her/his graduation.

(4) Evaluation through an interview by the Selection Committee

In the interview, the Selection Committee will examine whether the applicant can go through a challenging and integrative research project that could possibly result in the exploration of a new field or the contribution to the settlement of social problems. The Selection Committee also examines whether the applicant has a global point of view and an ability to contribute to science, technology, and innovation in Japan. To this end, the interview will be held in English for the Japanese applicants. The foreign applicants should introduce her/himself and explain her/his research project in Japanese; for the rest of the interview, the foreign applicants are recommended to speak in Japanese although they may sparingly speak English.

9. Obligations of students eligible for support

According to the aim of this program, the scholarship recipients should carry out the following obligations. The recipients are strongly advised to apply for a JSPS Research Fellowship for Young Scientists (DC2).

- (1) Devote yourself to research based on the research plan proposed at the time of application.
- (2) Engage in the internship or study abroad plan proposed at the time of application.
- (3) Every year, submit at least one manuscript to a peer-reviewed journal or make at least one presentation at an international conference.
- (4) Participate in the University's special educational programs for improving research capabilities, etc.
- (5) Report on the status of your ongoing research at the campus meeting held on a regular basis.

- (6) Students must be interviewed by their supervisor and associate supervisor on a regular basis.
- (7) Attend and complete the e-learning program of the Association for the Promotion of Research Integrity (eAPRIN).
- (8) Registration to the system operated by the National Council for the Promotion of Job-Based Research Internships.
- (9) Register in the Japan Graduates Database (JGRAD) operated by the National Institute of Science and Technology Policy of the Ministry of Education, Culture, Sports, Science and Technology (MEXT). The student must also report promptly any decisions made regarding his/her career path after completion of the program.
- (10) Cooperate in various surveys related to the Project.
- (11) Carry out tax law procedures such as tax declaration for research incentive expenses.

10. Tax law procedures, etc.

Although there is no employment relationship between the student and the University, the research scholarship is treated as miscellaneous income under the tax law and is subject to income tax and inhabitant tax. Therefore, it is necessary to file an income tax return, and appropriate measures must be taken. In addition, please inform your parents or other persons responsible for your dependents of this fact and ask the person in charge at their workplace about the treatment of your dependents in terms of health insurance, support allowance, and so on.

11. Handling of personal information

- (1) Personal information such as names and other personal information provided in the application form will be used for screening of documents and interviews, as well as for the performance of duties related to this project.
- (2) The names, affiliations, photographs, etc. of the recipients will be used for publication on the website and in various reports and other printed materials.
- (3) The names and affiliations of the recipients will be used as a record of the project activities, and photographs of classes, events, etc. will be used for publication in reports and other printed materials and on the website.
- (4) This project is funded by the Japan Science and Technology Agency (JST), JST will directly follow up with the supported students regarding the implementation status of the project, etc. JST will also ensure that the supported students have access to the department in charge at JST, directly receive their opinions, etc., and use the results directly in the evaluation of this project. We will provide JST with the names and other personal information listed in the application form, as well as e-mail addresses and other information that will enable us to contact you, and we ask for your cooperation when we receive requests for evaluation and other surveys.
